other like offense under the law of another state or federal law. A list of these offenses is attached.

- b. An applicant may be approved as a foster parent or adoptive parent if:
 - i. The applicant, employee, or any other person living in the applicant's home who is 14 years of age or older and not in the conservatorship of DFPS has some other criminal history other than the felony offenses listed above;
 - ii. The applicant, employee or any other person living in the applicant's home who is 14 years of age or older and not in the conservatorship of DFPS has a misdemeanor or felony conviction under the Texas Controlled Substance Act, S46.13 (Making a Firearm Accessible to a Child), Chapter 49 of Title 10 of the Texas Penal Code *or any other like offense under the law of another state or federal law within the last 10 years.* A list of these offenses is attached under Other Offenses.
 - iii. DFPS determines that the person with the criminal history poses a minimal risk to the health and safety of children and submits the request for evaluation of risk to the Director of Child-Care Licensing; and
 - iv. In response to the DFPS request for an evaluation of risk, the Director of Child-Care Licensing determines that the person with the criminal history poses no risk to the health and safety of children.
- c. An applicant will not be approved as a foster or adoptive parent if the applicant, employee, or any other person living in the applicant's home who is 14 years of age or older and not in the conservatorship of DFPS is indicted or is the subject of a criminal complaint that has been accepted by a district or county attorney for any felony offense under S15.031 (Criminal Solicitation of a Minor) of Title 4, Title 5 (Offenses Against the Person), Title 6 (Offenses Against the Family), Chapter 29 (Robbery) of Title 7, S38.17 (Failure to stop or Report Aggravated Sexual Assault of a Child) of Title 8, S42.072 (Stalking), and Chapter 43 (Public Indecency) of Title 9 of the Texas Penal Code, *or any other like offense under the law of another state or federal law.* A list of these offenses is attached.
- d. An applicant may be approved as a foster parent or adoptive parent if:
 - i. The applicant, employee or any other person living in the applicant's home who is 14 years of age or older and not in the conservatorship of DFPS is indicted for or is the subject of a criminal complaint accepted by a district or county attorney regarding a crime other than the felony offenses listed above;
 - ii. DFPS determines that the person with the indictment or criminal complaint poses a minimal risk to the health and safety of children and submits the request for evaluation of risk to the Director of Child-Care Licensing; and
 - iii. In response to the DFPS request for an evaluation of risk, the Director of Child-Care Licensing determines that the person with the criminal history poses no risk to the health and safety of children.

I have read this form in its entirety, including the attached list, and I agree that this information may be verified by the Texas Department of Family and Protective Services. I further understand that the

inclusion of any false information or the omission of any requested information is cause for denial of my foster and/or adoptive parent application, or subsequent closure of my foster or preconsummated adoptive home. I agree to inform the department if this information changes any time during my employment or participation in the foster care or adoption program.
